III. COMPANY REQUIREMENTS:

1. Contractor/Agency must have been operational within the last 5 years. (To be verified thru company's DTI Cert. or SEC cert.)

IV. TIMELINE:

 GPS Trackers must be installed within Fourteen (14) Calendar days reckoned from the receipt of the P.O.

NOTE: Delays due to work stoppage ordered by GSD shall not be counted against the set completion date.

V. OTHER CONDITIONS OF THE CONTRACT:

- a. GPS Tracking Devices to be supplied are brand new and factory manufactures. Refurbished or make-shift devices will not be accepted.
- b. GPS Tracking Devices for ESB and PIP must be installed in their site offices.

VI. MAINTENANCE PROVISIONS:

• A Technician shall be provided within Three (3) working days by the contractor, if ever malfunction of the GPS tracking device may happen.

VII. WARRANTY PROVISIONS:

• The Warranty shall be a One (1) year manufacturer's warranty for the device reckoned from the receipt and installation.
