## **TERMS OF REFERENCE**

## Scope of Work:

A third-party pest control provider will conduct an area survey and propose appropriate methods for each location. They will ensure that all chemicals used are safe for PNOC's property and the surrounding ecosystem.

The Pest Control Program will be implemented park-wide, covering both the Administration Area and all operational locations that are critical for service delivery. The activities include:

- 1. Soil Poisoning (SP) and Drilling (DR) Application of pest control solutions to soil and cemented areas.
- 2. Wood Drenching (WD) Spraying of pest control solutions on wooden walls.
- 3. Termite Abatement Maintenance Program (TAMP) Comprehensive termite elimination strategy.
- 4. Mound Demolition Destruction of termite colonies.
- 5. General Pest Abatement Program Addressing other pests, such as rats and mosquitoes.

#### **TERMS AND CONDITIONS**

- Payment Terms: Government Terms full payment upon completion of delivery/implementation, or subject to the conditions specified in the Scope of Works/Activities or Terms of Reference.
- 2. All entries shall be typed or written in a clear legible manner.
- 3. Bidder shall offer one (1) bid only. Alternative bids shall be rejected.

- 8. During evaluation of quotation/proposal, the project proponent may require additional documents to verify, validate and ascertain the compliance of the supplier/contractor or consultant.
- Liquidated damages shall be imposed pursuant to Section 68 of the Revised IRR of RA 9184.

# INSTRUCTIONS AND PROCEDURES FOR ONLINE SUBMISSION OF QUOTATIONS/PROPOSALS FOR SMALL-VALUE PROCUREMENT

1. Interested bidders must submit proposal/quotation in a single portable document format (PDF) via email address <a href="mailto:newprocurement@pnoc.com.ph">newprocurement@pnoc.com.ph</a>

File format should be:

Note: RFQ Reference Number is located at the front page of the request for quotation.

#### **Email Format Instructions:**

- a. The subject line must indicate the RFQ Reference Number
- b. The email body must include the following details:
  - i. Project Title
  - ii. Name of the company and its authorized representative
  - iii. Contact details such as telephone/mobile number and email address

Proposal/quotation must be in a single PDF file only and must not exceed 25 MB.

- 2. Bidders will be immediately notified via email of the receipt of the proposal/quotation.
- Proposal/quotation submitted late based on system timestamp will be automatically disqualified.
- 4. A bid opening will take place immediately after the deadline through video conferencing. The meeting link will be sent to participating bidders upon request.
- 5. Upon opening, the BAC shall verify the presence or absence of the specified requirements in the quotation/proposal. All eligible quotations/proposals will undergo further evaluation.
- The award of contract shall be made to the Lowest Calculated Responsive Quotation or Highest Rated Responsive Bid, which complies with the minimum technical specifications and other terms and conditions. The result will be posted on the website and the official social media sites of PNOC.
